April 2025

All students who are absent for one or more Common Assessments must submit a doctor's note or other pre-approved relevant documentation in order to be approved to make-up the assessment(s). Students who miss one or more Common Assessment and fail to submit documentation with the date of the assessment on it will not be permitted to make-up their assessment(s), and they will receive a zero on any assessment they missed.

Only emergency excusals will be considered and must be approved in advance by a member of the administration. Planned absences for family vacations, weddings, college visitations, and all other events that do not fall within the emergency excusal policy will not be approved for a make-up exam.

Any student who is excused by the administration from a common assessment will be required to make up the common assessment on the respective make-up days, Thursday, June 12, 2025 and Friday, June 13, 2025.

FOURTH QUARTER COMMON ASSESSMENT EXEMPTION POLICY

Seniors who earn an overall unweighted course average of 90 or higher (including common assessment, with no one marking period grade below 85) can be exempt from the 4th quarter common assessment. To clarify, marking period grade below 85 does not include common assessment grades. Seniors cannot be exempted from a project-based common assessment. Students who choose the 4th quarter exemption should be aware that the average of their first two common assessments will count toward 20% of their final grade average. Students may opt to take any 4th quarter common assessment even when exempt.
